

History

The Burnaid® range was developed in Australia in the 1970's, to provide first responders with a quick, simple and effective way to apply first aid for burns in the home and workplace, allow ease of transport to specialist care, and allow ease of specialist removal, assessment and treatment of the burn wound.

How does Burnaid® work?

The Burnaid® range consists of specially formulated sterile hydrogel consisting of in excess of 90% water. The Burnaid® Dressing is made up of a Polyester urethane 3mm sheet impregnated with hydrogel. Burnaid® is also available in sachets and spray gel, for the immediate first aid treatment of minor burns, scalds and sunburn.

Fast Pain Relief

Burnaid® Hydrogel offers fast pain relief in a first aid situation by cooling the burn, donating moisture to the burn and providing a sterile barrier against contamination. Burnaid® Hydrogel aids cooling by providing evaporative cooling of the water based gel off the skin. The Burnaid® hydrogel also acts as a heat sink, drawing heat out of the burn. The cooling properties help in stopping burn progression, and the hydrogel is designed to prevent desiccation and therefore assists in the healing process.

Moisture Donation

The Burnaid® range consists of specially formulated sterile hydrogel consisting of in excess of 90% water.

Sterile Non Adherent Barrier

Burnaid® dressings provide a sterile physical barrier against contamination and further damage to the burn wound whilst being transported to medical care. The dressing does not adhere to the wound. Upon reaching medical care, the dressing can be easily removed and the hydrogel rinsed off with water allowing easy assessment and treatment.

FAQ on Burnaid®

1. Can Burnaid® dressings be used on deep or full thickness burns?

Yes they can. Burnaid® dressings can be used on all burns, from sunburn superficial, partial and full thickness burns, even where there are open skin wounds. Burnaid® dressings are sterile and will help protect the wound and keep it moist.

2. Are there concerns with regard to irritation or allergies?

The Burnaid® range has been tested for cytotoxicity, sensitization and irritancy. It is considered to be non-toxic and a non-irritant.

3. Will Burnaid® range cause Hypothermia?

Any type of cooling modality has the potential to cause hypothermia. Placing the Burnaid® dressing directly over the affected area cools the burn and avoids rapid cooling on other body surface area as does showering or hosing the patient. Care should be taken to avoid hypothermia especially in those patients who are most at risk; infants, elderly and those with large surface area burns. It is recommended that hydrogel dressings are not used on children and the elderly if it covers more than 10% of the Total Body Surface Area (TBSA), and for adults no more than 20% TBSA. Many countries have protocols that require the dressing to be covered with a space blanket or cling film - which can help regulate the cooling affect. Check local protocols in your area.

4. I have been told I cannot use any creams or lotions on burns and only water?

That is correct. Creams or lotions may petroleum or waxed based and can trap heat on the wound. They can also cover the wound in a film like substance and make wound assessment for medical practitioners difficult.

5. How long can you keep Burnaid®?

Burnaid® dressings, hydrogel spray and sachets are sterile products that have a shelf life of 5 years from date of manufacture if stored correctly in a cool dry place below 30°C.
